## About this form



The federal government imposes rules for the insurance you have through your super.

To prevent insurance premiums from eroding super balances in inactive accounts, we're required to end cover on inactive accounts – which have not received a contribution for the past 16 months – unless the member opts in to keep their cover.

By completing this form, you are opting to keep your insurance cover, even if your account is not receiving contributions, and agreeing to keep paying premiums from your super account.

Your cover will be continued until you ask us to cancel it or until it ceases for another reason under the Insurance Policy.
